COA Ken Dawson presented the **Acceptance of lowest responsive bid for Lamar Dixon Soccer Complex, Project No. 2015.001.** He stated that on June 9, 2016 the Purchasing Department received two bids for the Lamar Dixon Soccer Complex. The bids were received from Industrial Enterprises and J. Reed Contractors. After review the Lamar Dixon Expo Center and Quality Engineering and Surveying, LLC recommend accepting the bid from J. Reed Contractors and authorizing the Parish President to begin negotiations for the project. A motion to approve was made by Councilman Aaron Lawler and seconded by Councilman John Cagnolatti.
