PURPOSE:

The Parish of Ascension hereby issues a Request for Qualifications (RFQ) from qualified Consultant Firms to provide Professional Engineering Services for Bridge Load Rating using the Load and Resistance Factor Rating Method (LRFR) of twenty-six (26) existing bridges in Ascension Parish. Consultants who are a Louisiana or Foreign LLC or Corporation should be appropriately registered with the Louisiana Secretary of State, as contemplated by Title 12 of the Louisiana Revised Statutes, and with LAPELS under its rules for FIRMS.

Firms or Consultants who are interested in providing services requested under this RFQ **must submit one (1) unbounded original and five (5) bound copies of qualifications by the date and time specified.** The information shall be received in hard copy (printed) version. Failure to submit the required number of copies may result in a finding of non-conformance. Originals should be clearly marked.
