- **Authorized under Section 404 of the Robert T Stafford Disaster Relief and Emergency Assistance Act**

FLOOD MITIGATION ASSISTANCE GRANT PROGRAM (FMA)

- **Funding appropriate annually by Congress on a competitive basis through the National Flood Insurance Fund (NFIF)**
- **Provided with the goal of reducing or eliminating claims under the National Flood Insurance Program (NFIP)**
- **Authorized by Section 1366 of the National Flood Insurance Act of 1968, as amended**
- **Homeowners must have flood insurance to qualify for the program**
